**Release, Waiver of Liability and Indemnity Agreement**

In consideration of being permitted to participate as a vendor at the Great Lakes Avicultural Society (G.L.A.S.) Bird Fairs. I agree to the following:

1. To release, discharge and waive any claims or causes of action against G.L.A.S. and/or the Delta Plex, as well as their respective officers, employees, agents and representatives, for any property loss, damages or injury to persons arising out of the aforesaid fair/show.
2. To indemnify and hold harmless G.L.A.S. and/or Delta Plex, as well as their respective officers, employees, agents, representatives, from any claim or action (including cost and expense in defending same) which is alleged to relate, directly or indirectly to my acts or omissions or the acts or omissions of my employees or agents.
3. Any disagreements or disputes arising from items bought or sold are between the buyer and seller. G.L.A.S. and/or Delta Plex are not responsible in any way and are exempt from action, legal or otherwise, from all disputes, sales, disagreements, theft, injury or death regarding vendors or vendor's property or merchandise.
4. G.L.A.S. reserves the right to refuse admittance of all birds or products the "fair Committee" determines to be inappropriate.

I agree that this release, waiver of liability and indemnity agreement shall be binding on my heirs, assigns, successors and representatives.

I have read the forgoing release, waiver of liability and indemnity agreement. I fully understand it's contents and I voluntarily enter into this agreement.

**Vendor Agreement**

**Be advised that G.L.A.S. DOES NOT allow the sale of unweaned baby birds. If you are caught selling unweaned baby birds you will be asked to leave without refund.**

Please read the following, sign & date and return with vendor application and Release Agreement:  
IF YOU ARE SHARING A TABLE, THAT PERSON "MUST" BE LISTED ON THESE FORMS  
AND MUST SIGN ALSO.

1. NO tables will be guaranteed without full payment  
All monies owed to G.L.A.S. by vendors must be paid before you can set up your table(s)  
The only animals allowed for sale are exotic birds.  
**No game birds, fowl or companion pets. Pigeons, Quail and Doves ARE allowed.**
2. This vendor hereby certifies, that to the best of his/her knowledge, all bird(s) being brought to the G.L.A.S. Bird Fair are healthy and free of any communicable disease. Further, this vendor certifies that he/she is not treating these bird(s) for a present infection of any kind that could be contagious to other birds or humans. The current feeding, by the vendor, of medicated pellets/foods or other such treatments for preventive purpose is allowed.  
**All birds have been owned and in said vendor's possession for a minimum of 45 days.**  
If your bird escapes you will be asked to stay "after" the fair to capture it. Please do not try and catch your bird during the fair, it disturbers other vendors and their birds.
3. Sale birds must be in good health and **WEANED**. Birds must be in clean cages & adequate size with adequate food and water. No selling of birds or products to be conducted outside the show hall. Birds at G.L.A.S. fairs are subject to an examination by a vet of G.L.A.S. choosing. All birds must be available for inspection. **No new birds will be allowed into the fair once the vet has inspected your birds. If you arrive after the veterinarian has left your birds will not be allowed into the fair.** G.L.A.S. reserves the right to remove any birds from the fair that are deemed to be in an unhealthy condition by the vet.  
**The Veterinarian's decision is final!**
4. The violation of any fair rule or regulation can result in being barred from selling at this year's fair, and at the discretion of the fair Committee, may result in similar action for upcoming years.
5. **Reservations are non-refundable.** They may be transferable, G.L.A.S. must approve the transfer and the new vendor MUST complete, sign and return a fair vendor registration form, vendor agreement and release and Waiver of Liability and Indemnity Agreement.
6. Fair hours to the public are 10:00 AM – 4:00 PM. Please be set up by 9:30 AM. Doors open to the public at 10:00 AM and remain open until 4:00 PM. After unloading all vendors must move their vehicles and trailers to the far end of the parking lot or to the back lot. Please allow the public to have the front of the lot.
7. Delta Plex will provide a concession stand.

**\*\*Reminder\*\*** The wall spaces are the first to go, so please don't wait until the last minute.
